For the voice controlled end rider with Honeywell technology, your operator only needs a headset¹ and basic voice commands to control the horizontal movements of the truck.

- Vehicle begins in manual mode
- Operator drives to rack
- Operator speaks a predetermined voice command
- Truck switches to auto mode and advances the pre-programmed distance
- Operator speaks a predetermined voice command to stop the truck
- Operator speaks a predetermined voice command to sound the horn at any time

Is the voice controlled end rider difficult to implement or complicated to learn?

No. The solution is easy to implement into your existing fleet, and actually shortens your order picking staff training time. The voice commands extend the truck's functionality with intuitive human thought and movement.
